##### Approval and publication of audited financial statements

Further to the company announcement dated 8 April, 2026 (CPT14) it is hereby announced that the Board of Directors of the Company has approved the audited financial statements of the Company for the financial year ended 31 December, 2025. Attached to this company announcement is a Directors’ Declaration on ESEF Annual Financial Reports.

During the year under review, the Company and its subsidiaries (the “Group”) generated €21.3 million in revenue and €3.1 million in profit before tax, reflecting a 22% profit growth compared to the previous year and a 6% improvement over the forecast published in the 31 October, 2024 prospectus.

##### Date of Annual General Meeting

The Board of Directors of the Company hereby announces that the next Annual General Meeting of the Company is scheduled to be held on 10 June, 2026 at 15:00. Shareholders on the register of members of the Company held at the Central Securities Depository as at 11 May, 2026 shall in due course receive notice of the Annual General Meeting and shall be eligible to attend and vote at the meeting. Further information and documentation relating to the Annual General Meeting will be made available to eligible shareholders at a later date in the notice convening the Annual General Meeting.

##### Dividend

The Board of Directors resolved to recommend to shareholders the payment of a final net dividend for the financial year ended 31 December, 2025 of €1,100,000, equivalent to €0.0177 (as rounded) per share having a nominal value of €0.10 each (the “Dividend”). If approved by the shareholders of the Company at the aforementioned Annual General Meeting scheduled to be held on 10 June 2026, such dividend will be paid to the shareholders of the Company appearing on the Company’s register of members maintained at the Central Securities Depository of the Malta Stock Exchange as at close of business on such date. Payment of the Dividend will be effected on or around 19 June, 2026.


